

CHAPTER 73: PARKING SCHEDULE

Schedule

I. Limited parking

SCHEDULE I: LIMITED PARKING.

(A) Limited parking shall be regulated at the following locations:

East College Avenue (south side) from 151 feet east from the intersection of East College Avenue with South Main Street	Parking limited to 10 minutes from 8 a.m. to 6 p.m. except on Sundays	4-4-58	
East College Avenue (south side) from 151 feet east from the intersection of East College Avenue with South Main Street except in a parallel position with the edge of the street, and in the spaces marked and designated with white paint for the parking	Parking limited to 10 minutes from 8 a.m. to 6 p.m. except on Sundays	4-4-58	
South Main Street (east side) from 220 feet south from the intersection of South Main Street with East College Avenue and the vehicles must be parked in an angle position with the edge of the street and in the spaces marked and designated with white paint	Parking limited to one hour from 8 a.m. to 6 p.m. except on Sundays	4-4-58	
South Main Street (both sides) from the stop light on South Main Street to Quinn Circle	Parking limited to one hour between 8 a.m. and 6 p.m. except on Sundays	6-6-72	
West College Avenue from the stop light to the lower Memorial Drive entrance	Parking limited to two hours	6-6-72	
North Main Street (both sides) from the stop light on North Main Street to the north end of the Campus Cubbard	Parking limited to two hours	6-6-72	

Boiling Springs - Traffic Code

East College Avenue (south side)	Parking limited to 10 minutes	4-4-58	
Off Street Public Parking Lot located at 109 South Main Street	Parking limited to one hour from 5 a.m. to 10 p.m. and shall be closed from 10 p.m. to 5 a.m. Monday through Sunday	8-3-99	
It shall be unlawful for any person, firm or corporation to park, or allow to be parked, a motor vehicle in any space marked by yellow paint or by ANo Parking@ signs		4-4-58	
It shall be unlawful for any person, firm or corporation to park or allow to be parked, a motor vehicle across the white lines designating the spaces for parking		4-4-58	

(B) Penalty.

(1) Any person, firm or corporation who shall violate any of the provisions of this schedule shall be subject to prosecution either criminally or civilly for the violation, as the town may elect. The penalty for the violation shall be a fine of \$15.00, if paid within ten days after receipt of a ticket, uniform citation or other notice of the violation; provided, however, that if the conviction of any person for violation of this chapter shall be obtained by relying upon the prima facie rule of evidence that the registered owner of the vehicle is the person who parked the vehicle in violation, as provided by G.S. 20-162.1, the penalty in the case shall be no greater than the amount designated by the General Statute section.

(2) In the event that the aforesaid fine of \$15.00 is not paid within ten days after receipt of a ticket, uniform citation or other notice of violation, the fine for the violation shall thereafter be \$10, plus any court costs that may be incurred by the town in an effort to enforce collection of the penalty.

(3) The payment of any fine or costs which may become due by virtue of this schedule may be made by the payment of the same to the office of the town clerk in the town hall during the normal operating hours of the office. (Ord. passed 4-4-58; Am. Ord. passed 12-1-87)
